**CANCELLATION/DOWNSIZING POLICY**

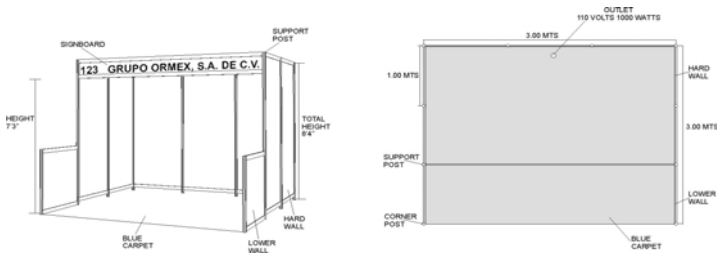

*Trade Show Consulting (TSC) and its authorized representatives are hereinafter referred to as "Show Management."*

## **1. ADMISSIBLE EXHIBITS**

Show Management reserves the right to accept or reject any application for exhibit space.

Equipment, products, or services exhibited (or referred to) must be those normally provided or produced by Exhibitor. Exhibitor shall not exhibit, offer for sale, give as a premium, or provide advertising or literature about equipment, products or services not manufactured or sold in the exhibiting company's name or company affiliated with the exhibiting company, except where such equipment, products or services are required, as determined by Show Management for the proper demonstration or operation of Exhibitor's display, in which case identification of such equipment, products or services shall be limited to the regular nameplate, imprint, or other identification which in standard practice appears normally on such equipment, products or in connection with such services.

Tools and accessories for equipment may only be demonstrated on machines manufactured by firms participating in AWS Weldmex-Fabtech Mexico.

## **2. SPACE ALLOCATION AND USAGE**

Whenever possible, space assignments will be made by Show Management according to the preference as to location requested by the Exhibitor. Show Management, however, reserves the right to make the final determination of all space assignments in the best interest of AWS Weldmex-Fabtech Mexico, and the Exhibitor acknowledges it is not entitled to any particular location. Show Management makes no representations or warranties with respect to the demographic nature and/or number of exhibitors and/or attendees.

Only one business or firm may exhibit in a single space. Exhibitor shall not assign, sublet, share, or transfer any part of the allotted exhibit space with another business or firm.

Exhibitor shall not permit representatives from other businesses or firms to use its booth for any purpose. It is the intent of Show Management that all companies providing equipment, material and services appearing at AWS Weldmex-Fabtech Mexico, as well as related sales personnel, be exhibitors with paid exhibit space.

## **3. CONSENT TO USE OF PHOTOGRAPHIC IMAGES**

Registration and attendance at or participation in AWS Weldmex-Fabtech Mexico constitutes an agreement by the registrant to Show Management's use and distribution (both now and in the future) of the registrant or attendee's image or voice in photographs, videotapes, electronic reproductions, or audiotapes of such events and activities.

## **4. LISTING AND PROMOTIONAL MATERIALS**

By exhibiting at AWS Weldmex-Fabtech Mexico, Exhibitors grant Show Management a fully-paid, perpetual non-exclusive license to use, display and reproduce the name of Exhibitors in any directory listing the exhibiting organizations at the Exhibition and to use such names in promotional materials. Show Management shall not be liable for any errors in any listing or descriptions or for omitting any Exhibitor from the directory or other lists or materials.

## **5. RIGHT TO OFFSET**

Show Management shall have the right to offset the amount of any obligation due and owing to TSC and its related entities from the Exhibitor whether under this agreement or any other agreement between TSC and its related entities and the Exhibitor. Show Management may cancel this contract in the event that the Exhibitor is past due on any amounts due to TSC and its related entities for any reason.

## **6. LIABILITY**

Exhibitor hereby agrees to indemnify and hold harmless the Show Management, its service contractors, the management of the exhibit hall and any of the officers, employees, agents, staff members or directors of any of the same, and their respective successors and assigns from and against any and all actions, causes of action, suits, claims, losses, liabilities, and damages ("Losses"), including without limitation losses for personal injury, death, property damage and loss of use of property by whomsoever sustained on or about or relating to Exhibitor's participation in AWS Weldmex-Fabtech Mexico. Show Management reserves the right to review any invoices incurred by Exhibitor related to show services which are provided by official service contractors.

## **7. FORCE MAJEURE**

In the event the exhibition facility or any part of the exhibit areas thereof are unavailable whether for the entire event or a portion of the event as a result of fire, flood, tempest, governmental intervention, malicious damage, acts of war, acts of terrorism, strike, lock-out, labor dispute, riot or any other event, cause or agency over which Show Management has no control, or should Show Management decide that because of any such event, cause or agency it is necessary to cancel, postpone or re-site AWS Weldmex-Fabtech Mexico or reduce the installation time, Exposition time, or move-out time, Show Management shall not be liable to indemnify or reimburse the Exhibitor in respect of any damage, liability or loss, direct or indirect, arising as a result thereof.

## **8. INSURANCE**

Exhibitors shall carry adequate insurance coverage, at their own expense, for property loss or damage and liability for personal injury.

Exhibitors, their agents, and employees assume risks of transportation, property damages, and loss of use in presenting their exhibits or equipment at AWS Weldmex-Fabtech Mexico. Exhibitor waives all claims of every kind against the Show Management, its service contractors, the management of the exhibit hall and any of the officers, directors, employees, agents or staff members of any of the same, including, without limitation, all claims for damages based on personal property damage or destruction, loss or theft, personal injury, cancellation of AWS Weldmex-Fabtech Mexico, failure or refusal to provide space for any exhibit, preventing the display, operation, removal or dismantling of any exhibit, or any other act or failure to act of the Show Management.

EACH EXHIBITOR, FOR HIMSELF/HERSELF AND HIS/HER EMPLOYEES AND AGENTS, AGREES TO BE BOUND AND TO ABIDE BY THE RULES AND REGULATIONS GOVERNING AWS WELDMEX-FABTECH MEXICO AND BY ANY AMENDMENTS THERETO IN CONFORMANCE WITH THE PRECEDING SENTENCE, WHICH RULES AND REGULATIONS ARE INCORPORATED HEREIN BY THIS REFERENCE.
